FAIRPORT HARBOR VILLAGE COUNCIL COUNCIL MEETING - REGULAR MEETING January 21, 2025

The Mayor called the Regular Meeting to order at 6:30p.m.

Chief David Koran led the Pledge of Allegiance.

Shaver moved and McKinney seconded to adjourn the meeting to Executive Session for the purpose to consider the appointment of a public official (Pro Tem appointment). All present voted Aye, motion unanimous. The meeting was adjourned. At the conclusion of the Executive Session, the Regular Meeting was readjourned.

Answering Roll call were Christina Bacnik, Jeff McKinney, Elisabeth Shaver, Frank Sarosy, Anthony Bertone and Jerry Hites.

Shaver moved and McKinney moved to appoint Frank Sarosy as Council President Pro Tem for 2025. All present voted Aye, motion unanimous.

Hites moved and Bacnik seconded to approve the minutes from the December 17, 2024 Regular council meeting. All present voted Aye, motion unanimous.

Hites moved and Bacnik seconded to approve the minutes from the January 7, 2025 Special council meeting. All present voted Aye, motion unanimous.

Administrator Darling reviewed his report of January 21, 2024 and advised, as well, regarding the Goods, Grants & Welfare Committee meeting, Active Transportation grant, Hometown Heroes has fille 26 of 28 slots, water rate study will be conducted by Ohio Rural Water. Bertone inquired regarding cyber security coursework and assistance, as available, from the State.

Village Engineer Lubonovic provided his update and advised on current projects as well as those currently in review. Lubonovic advised that the water tower was nearly complete and that Great Lakes Construction is the apparent lowest and best bid for the 5th Street stormwater project.

Fiscal Officer Page reviewed the Financials for December reporting \$252,450.21 in revenue and \$394,889.02 in expenditures for December, interest earned was \$14,208.31. For the year 2025, revenue was \$4,803,623.56 and expenditures were \$5,157,745.17. The reconciled balance at December 31, 2024 was \$3,746,644.53.
